EOLIS Belgium is a multi-service logistics company, subsidiary of the Company Fruitière Group (Marseille, France), a leading producer and distributor of fruits and vegetables worldwide. We are specialized in the import-export, transport and forwarding of goods.

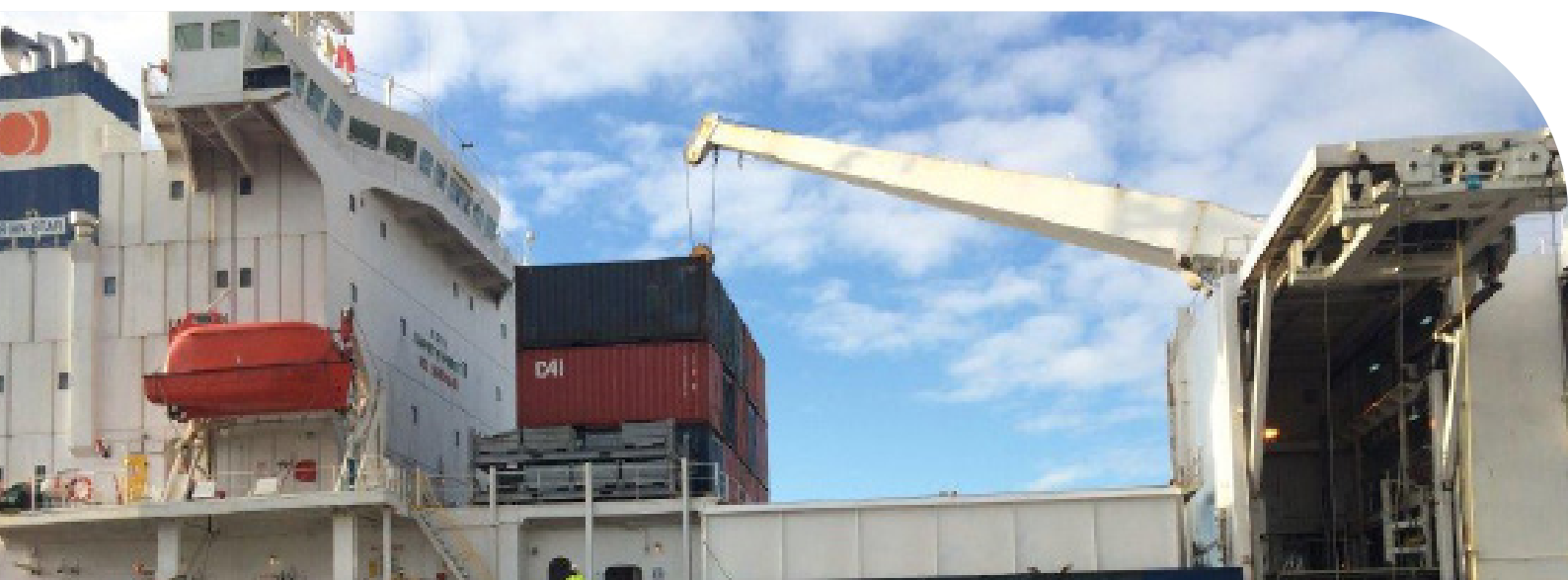
The company is located in the port of Antwerp-Bruges, Europe's second largest port with more than 300 liner services and 800 destinations, offering an international panel of connections and handling millions of tons of maritime cargo every year.

Our teams benefit from a large experience in logistics and transit services but also from permanent connections between Africa and Europe provided by our partnerships with Africa Express Line (AEL) and EAGLE.

We also rely on a solid partnership with Eurofruitports (EFP) in the form of a joint venture between Compagnie Fruitière and Euroports Breakbulk Terminal, our logistical partner in the port of Antwerp. EFP offers excellent connections to hinterland destinations via mainroads and sufficient barge connections to the important European ports. It is located on a 1,900 m quay length with two dedicated fruit berth, a storage capacity of 500 000 tons and a maximum draft of 13.94m. The company is specialized in handling fruits and perishables (mainly bananas) and operates from a 38.700 sqm multi-purpose water bound terminal containing:

- 13.600 sqm coldstore
- 8.100 sqm dry warehouse for export
- Container hub & repair site of 17.500 sqm and 500 reefer plugs

Backed by our expertise, sea fleet and certifications, we guarantee our customers a regular assistance in their shipments and safe customs procedures for their exportations.

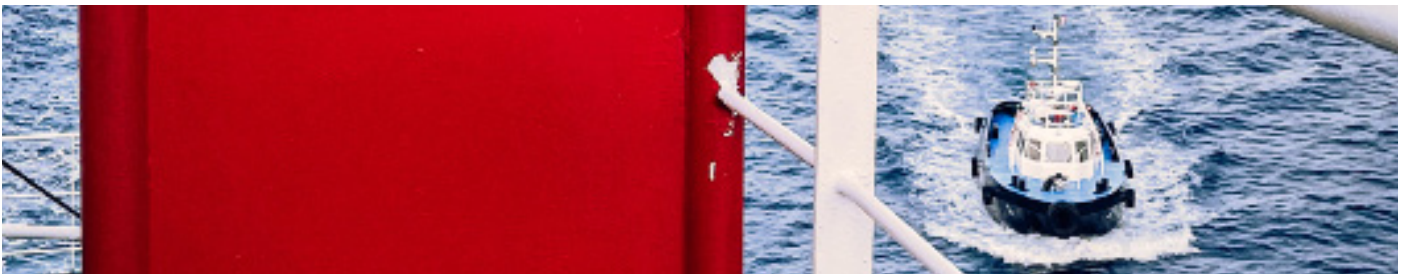
